# □ 4. Ward or Dependent of the Court

\* A student is a ward of the court if it has assumed legal custody of him/her. In some states the court may impose its authority over a juvenile who remains in the legal custody of his/her parents; such a student is not a ward of the court. Also, incarceration of a student does not qualify her as a ward of the court.

  the court until age 18, or a letter stating that you are a participant in the
  Independent Living Program (ILSP), or other court documentation showing that
  you were removed from your home because it posed a direct threat to your
  well-being.
